YOU ARE INVITED TO SEND A TEAM MADE UP OF YOUR FIVE (5) HIGHEST AVERAGE WOMEN BOWLERS WITH THEIR HIGHEST INDIVIDUAL USBC CERTIFIED LEAGUE AVERAGE IN YOUR ESTABLISHMENT (AT LEAST 2/3rds OF THE REGULARLY SCHEDULED LEAGUE SEASON) TO REPRESENT YOUR LANES IN THIS ANNUAL USBC CERTIFIED TOURNAMENT. (NO SUBSTITUTE AVERAGE ALLOWED.) ALL ENTRANTS MUST BE MEMBERS OF USBC. A BOWLER MUST COMPETE FOR THEIR HIGHEST AVERAGE HOUSE, IF ELIGIBLE.

EACH HOUSE MAY ENTER MORE THAN ONE TEAM FOR PARTICIPATION SHOULD THEY DESIRE. HOWEVER, THE FIVE HIGHEST AVERAGES MUST BE COMPRISE ONE TEAM AND THE NEXT FIVE HIGHEST WILL COMPRISE THE NEXT TEAM.

EACH BOWLER WILL RECEIVE A HANDICAP BASED ON 90% OF THE DIFFERENCE OF HER AVERAGE AND 220. AVERAGE AS OF APRIL 1, 2017.
