## FORT WAYNE METRO USBC - SUMMIT CITY WOMEN'S OPEN RULES

1. USBC certified Tournament. Entry is open to **ANY & ALL USBC SANCTIONED FEMALE BOWLERS**. Entrants must have an USBC certified average of 21 games or more from the 2023-2024 season or a minimum of 12 games in 2024-2025 current average as of JANUARY 31st, 2024. **Proof of membership must be provided for non Fort Wayne Metro USBC members.**
  2. Tournament will have ONE STANDARD ADULT DIVISION. Handicap for players will be 90% of their average from 200. A SCRATCH SIDE OPTION is offered for interested participants. The 10-pin rule will be in effect. Any bowler having an average 10 pins HIGHER than last year's 2023-2024 AS OF JANUARY 31st, 2025 must declare the higher average (**21 GAMES MINIMUM**).
  3. At least 1 in 5 will cash in STANDARD division. SCRATCH OPTIONAL DIVISION WILL PAY 1 in 10. 100% OF PRIZE FUND WILL BE RETURNED.
  4. **FORMAT:** Each participant will roll FOUR (4) GAMES OF QUALIFYING. Participants will move ONE PAIR TO THE RIGHT after EACH Qualifying Game. The TOP 16 WILL ADVANCE TO MATCH PLAY.
- MATCH PLAY:**  
ROUND OF 8 - SINGLE-GAME HEAD-TO-HEAD MATCHES: (1 VS 8, 4 VS 5, 2 VS 7, 3 VS 6).  
WINNER WILL BE DETERMINED BY TOTAL PINS WITH HANDICAP TO ADVANCE.  
FINAL FOUR: The remaining FINAL FOUR participants will participate in "Stepladder Finals" (Single Game Elimination Match) until a CHAMPION is crowned.
5. **STARTING PAIRS WILL BE PRE-ASSIGNED AND MADE PUBLIC AT CHECK-IN.**  
CHECK-IN: 9:00 A.M. / PRACTICE: 9:45 A.M. / COMPETITION: 10:00 A.M.
  6. Bowlers are responsible for verifying their average, if the submitted average is lower than required and results in a lower classification or more handicap, the bowler's score WILL BE disqualified. If submitted average is higher than required, prize winnings will be based on the submitted average.
  7. Violation of tournament rules will carry the penalty of disqualification of the bowler with no refund.
  8. The decision of the tournament director shall be final unless an appeal is made in accordance with USBC Rule 329. All USBC rules are enforced.
